 - Maintenance of knowledge/skills
 - Teaching & examination
 - Research & publication
- Random verification 2.5%

CPD Program

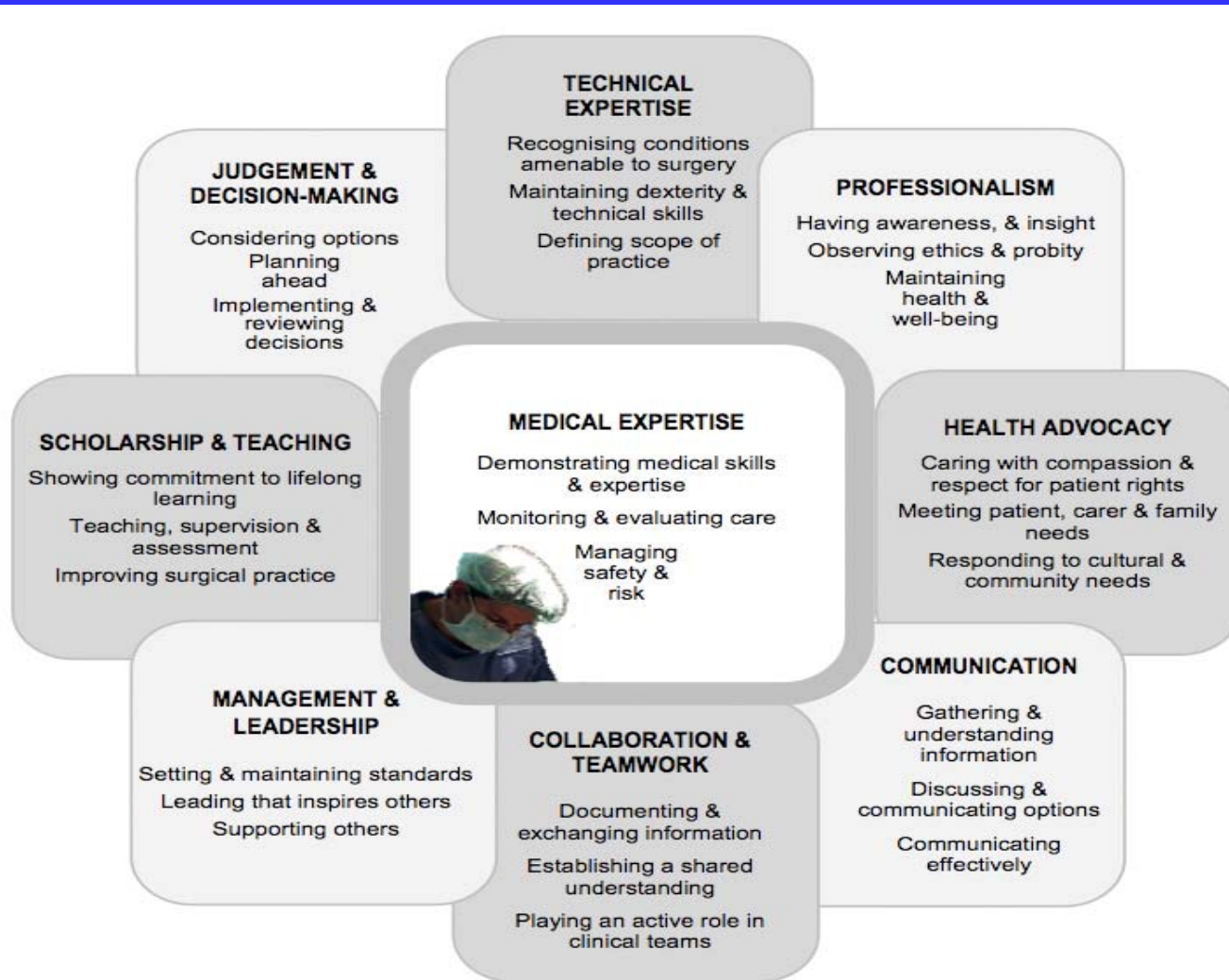
- Robust & evidence based
- 94% compliance
- But what does it mean?

- Competence and performance framework
 - MIAA – funding from insurers

 - Patterns of behaviour
 - Measurable behavioural markers

How effective?

Workshops and courses

- 2001 2 events 36 participants
- 2008 58 events 1028 participants
 - Fellows, trainees, IMGs, other

- Course evaluation
 - Response/reaction
 - Learning/likely practice change
 - Transfer/performance



How effective?

Risk management – 3 month follow up

- Improved relationships with patients
 - Changes to consent process
 - Involving patients in decision making
 - Allowing patients time to tell their story
 - ‘Compulsory’ post-operative consultation
- Improved practice systems
 - More effective patient tracking
 - Better documentation
- Role of staff in risk minimisation
 - Better telephone communication
 - Improved reception skills
